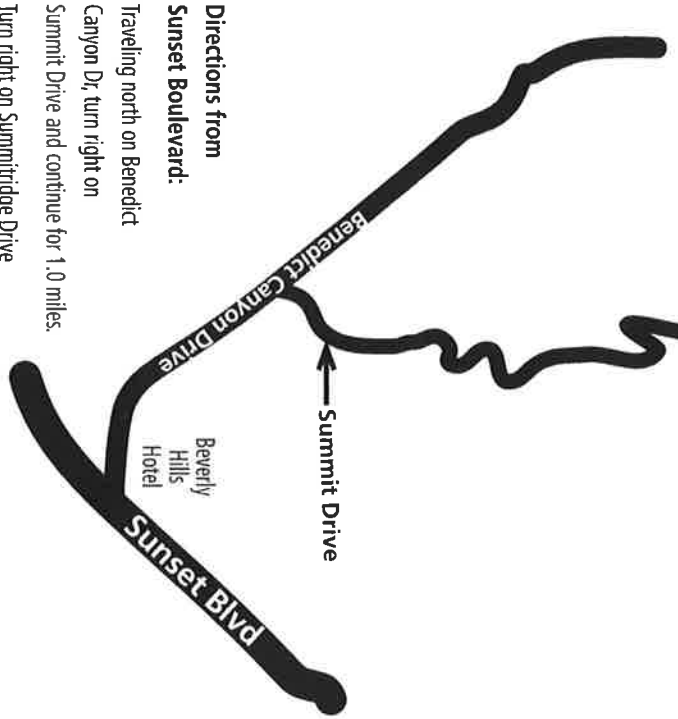

CONTRIBUTIONS TO VICTORY 2010 ARE UNLIMITED. UNLESS YOU PREFER OTHERWISE, YOUR VICTORY 2010 CONTRIBUTION WILL BE DEPOSITED IN THE FOLLOWING MANNER:

**Individual (non corporate) Contribution – check or credit card signed by one person**

First \$10,000 will be allocated as federal dollars Next \$10,000 will be allocated as Levin dollars

Next \$32,400 will be allocated as state candidate dollars

Any dollars in excess of \$52,400 will be allocated as state non candidate dollars

**Couple (non corporate) Contribution – check or credit card signed by both spouses**

First \$20,000 will be allocated as federal dollars

Next \$20,000 will be allocated as Levin dollars

Next \$64,800 will be allocated as state candidate support dollars

All dollars in excess of \$104,800 will be allocated as state non candidate dollars

**Corporate/PAC or Association Contribution**

First \$10,000 will be allocated as Levin dollars

Next \$32,400 will be allocated as state candidate support dollars

All dollars in excess of \$42,400 will be allocated as state non candidate dollars

**UNDER PROPOSITION 34 & THE BI-PARTISAN CAMPAIGN REFORM ACT (BCRA) THE CALIFORNIA REPUBLICAN PARTY IS REQUIRED TO HAVE FOUR ACCOUNTS:**

**FEDERAL ACCOUNT:** Limited to \$10,000 per year per donor. Corporate contributions not permitted. Contribution counts against donor's 2009-2010 aggregate limit of \$57,500 to national parties, state and local parties and federal PACs.

**LEVIN ACCOUNT:** Required under BCRA. Limited to \$10,000 per year per donor. Mandatory funding source for all voter registration and GOTV efforts 120 days out from Election Day. Corporate and business contributions are permitted. Contributions are reported by donor on state Major Donor Reports.

**CANDIDATE SUPPORT ACCOUNT:** Limited to \$32,400 per year per donor. Unlimited in what it may contribute to a specific candidate or spent on voter contact for the benefit of a specific candidate.

**STATE NON CANDIDATE ACCOUNT:** Unlimited in the amount it may receive. May spend on all non-candidate related activities such as Voter Registration (up to 120 days out from election), Voter ID, Research, Polling, Consultants and Party Operations.

Corporate contributions to Victory 2010 will be used in California state elections. These contributions may be made in any amount. Individual contributions will be used in both federal and California state elections and may also be made in any amount. Federal and California law requires political committees to report the name, mailing address, occupation and employer for each donor whose contributions aggregate \$100 or more per calendar year. Contributors of \$10,000 or more to CRP and all other state and local candidates, PACs, political party committees and ballot measures in a calendar year must file California "Major Donor Committee" reports during that calendar year. Contributions to Meg Whitman for Governor 2010 and to the California Republican Party's "Victory 2010" program are non-tax deductible for Federal or California tax purposes.
